What is the interest rate? It's a variable rate, as shown in the table below.

Your interest is calculated daily and paid monthly.

Can Bank of Scotland change the interest rate? Yes. As this account pays a variable rate of interest the rate can change over time. The bank will take into account a number of factors in determining rates at any given time, for example we might review the interest rate if the Bank of England Bank Rate changes. We'll always let you know of any planned changes to the rate. Our terms and conditions explain when and how we do this.

What might the future balance be? Below is an example of what the future balance might be, after interest has been paid. These projections are provided for illustrative purposes only and do not take into account the individual circumstances of the customer.

Initial Deposit	Gross Rate	Balance at 12 months
£1,000,000	0.05%	£1,000,500.11
£250,000	0.05%	£250,125.03
£100,000	0.05%	£100,050.01
£50,000	0.05%	£50,025.01
£1,000	0.05%	£1,000.50

This example assumes that:

- ▶ you don't withdraw any money and interest isn't paid out of the account
- ▶ the interest rate stays the same
- ▶ interest is paid monthly
- ▶ you make your initial deposit payment on the day you open the account
- ▶ you don't make any further deposits

How do I open and manage my account?

This account can be opened and managed in branch, by phone or online.

To apply for our Business Instant Access Account you should:

- ▶ have an annual turnover between £3m and £25m
- ▶ require the account for business use
- ▶ be a sole trader, partner or director
- ▶ be aged 18 or over
- ▶ have a minimum deposit balance of £1 and a maximum balance of £5m

Can I withdraw money?

You can make withdrawals from this account and there are no charges for doing so.

Additional Information

Statements can be issued monthly, quarterly or annually, as requested.

You can close this account at any time. We may ask you to confirm in writing.

AER stands for Annual Equivalent Rate and illustrates what the interest rate would be if interest was paid and compounded once each year. As every advertisement for a savings product, which quotes an interest rate, will contain an AER you will be able to compare more easily what return you can expect from your savings over time.

Gross rate means we will not deduct tax from the interest we pay on money in your account. It's your responsibility to pay any tax you may owe to HM Revenue and Customs (HMRC).
